5. PROJECT UPDATES

5a. Exhibitions and Residency: Colleen Donohoe, Project Coordinator reported the following:

Scottsdale Public Art's 2016-2017 Summer Exhibition *Bird Cloud Island* was a blockbuster exhibition with a total attendance of 38,171, and 6 workshops with 326 RSVPs.

Frankenstein in the 21st Century: The Waking Dream, 200 years later, is on display until December 30, 2017. There are multiple workshops coming up for the exhibition.

The Creative Residency @ Scottsdale Livery has just concluded Christopher Jagmin's *Safe and Sound: A series of social practice projects*. 6 workshops and 1 lecture were provided with 275 people in attendance.

Scottsdale Public Art has been awarded a new 3-year lease for the use of the Scottsdale Noriega Stable Livery space. There will be collaboration with Scottsdale Arts Education on programming, and our next Artist in Residence will be Choi + Shine, one of our selected artists for Canal Convergence November 2018.

5b. Scottsdale Waterview Public Art: Kevin Vaughan-Brubaker, Public Art Manager reported the following:

A presentation including examples of Artist's comprehensive public art designs for other park/trail way sites was given. Kevin encouraged the board to discuss ideas and concerns about the Waterview project. Several board members expressed concern over the budget and use of funds for structural items not related to actual artwork. A conversation ensued. Chris Irish, tabled the discussion in order to gather and distribute more information on the project.

7. BOARD OF TRUSTEES UPDATE

Chris Irish reported the following:

Scottsdale Arts Board of Trustees is compiling information from multiple sources to help aid in defining the role of the CEO.
