1. **CALL TO ORDER- -** Meeting was called to order at 12:02 p.m.

#### 2. CONSENT AGENDA-

2a. Consider Motion to Approve July 14, 2021, Minutes

A motion was made by Allison Colwell, and seconded by Erik Peterson, to approve the consent agenda. The motion passed unanimously.

### 3. ACTION ITEMS

**3a.** Consider Motion to Approve Preliminary Public Art Plan, Art in Private Development Project, Maya Hotel (Scottsdale Collective) - Kim Boganey, Public Art Director

Valerie Vadala Homer (art consultant), Adam Valente (senior project design architect, RSP Architect Limited), and Shawn Yari and Boyce O'Brien (Stockdale Capital Partners) presented a brief overview of the new Art in Private Development project Maya Hotel (Scottsdale Collective). The presentation included the development information and proposed public art potential for the site.

A motion was made by Elan Mizrahi, and seconded by Chris Irish, to approve the preliminary public art plan for Art in Private Development project Maya Hotel (Scottsdale Collective). The motion passed unanimously.

**3b.** Consider Motion to Approve Concept Design, Drinkwater Underpass Public Art Project – Kim Boganey, Public Art Director

Barbara Grygutis presented a brief overview of her public art concept design for the Drinkwater Underpass public art project. She provided renderings of the design, including details of the potential variations for the site. Kim Boganey provided a brief overview of the estimated budget and timeline for the project. A discussion amongst board members ensued. Concerns about lighting and artwork size in the proposed location were presented to public art staff and the artist. Kim assured board members that public art staff

and the selected artist are working closely with city staff to ensure safety and scale needs for the space are being met.

A motion was made by Jaime Neufer, and seconded by Erik Peterson, to approve the concept design for the Drinkwater Underpass public art project. The motion passed with 11 yea votes and 3 no votes.

**3c.** Consider Motion to Approve Final Design, Waterfront Splash Pad Public Art – Kim Boganey, Public Art Director

Annette Coleman provided a brief overview of her final concept design for the Scottsdale Waterfront Splash Pad. A discussion amongst board members ensued. Concerns about safety of the concrete mosaic orbs with the public were discussed. Design of the proposed background wall in the concept was a major concern for safety. Overall aesthetic for the site was addressed by board members. Feedback will be provided to the artist. Updates for board members will be provided at a later date.

An amended motion was made by Erik Peterson, and seconded by Melody Salamo, to approve the final design with modifications for the Waterfront Splash Pad public art project. The motion failed with 8 no votes, 5 yea votes, and 1 abstention.
