2a. Consider Motion to Approve February 9, 2022, Minutes

#### 3. ACTION ITEMS

3a. Consider Motion to Approve Gateway Markers, Final Design – Tanya Galin, Public Art Manager

Tanya Galin introduced selected artist Moazam Khan, principal architect at MoD a+p design firm. Khan provided an overview of the gateway markers final design. This design will replace current gateway markers at 13 locations around Scottsdale. Board members were informed that Scottsdale Public Art will manage the project through to the final design. The City of Scottsdale will be taking over the fabrication and installation process of the markers.

A motion was made by Carter Unger and seconded by Christine Kovach, to approve the gateway markers final artwork design. The motion passed unanimously.

**3b.** Consider Motion to Approve Bell Road Sports Complex Public Art, Final Design – Jennifer Gill, Public Art Manager

Jennifer Gill introduced selected artist Mary Shindell for the Bell Road Sports Complex final design. Located at East Bell Road and North 94<sup>th</sup> Street, Shindell is commissioned to create fence panels at the new outdoor complex for flat field sports. Art screen images of the designs were provided to board members. Timeline and budget details were presented to the board.

A motion was made by Chris Irish and seconded by Jessicah Amrine to approve the Bell Road Sports Complex final artwork design. The motion passed unanimously.

**3c.** Consider Motion to Approve Portable Works Acquisitions – Wendy Raisanen, Curator of Collections and Exhibitions

Wendy provided a brief overview of two artworks to be acquired into the City of Scottsdale's portable artworks collection.
