- 1. CALL TO ORDER- Meeting was called to order at 12:00pm
- 2. CONSENT AGENDA-

2a. Consider Motion to Approve March 13, 2024, Minutes

A motion was made by Jeff Miller and seconded by Jaime Neufer to approve the consent agenda, as amended. The motion passed unanimously.

3. "Know Your Public Art" Trivia: One Eyed Jack – Russel Grossman, SPA Advisory Board Member

SPA board member Bryanna McHenry will prepare trivia questions for the May meeting.

4. ACTION ITEMS

4a. Consider Motion to Approve Drinkwater Underpass Artwork Completion, *Breakaway*, artist Barbara Grygutis – Tanya Galin, Public Art Manager

Tanya provided a summary of the project with a \$1,139,487 artist budget. As a result of construction occurring to repair the aging infrastructure of the Drinkwater underpass and Civic Center Mall, an opportunity was realized to install a public art installation to serve as a gateway to the mall corridor and as a marquee for the City of Scottsdale. The aluminum cast knots are over 300 feet long on each

side of the underpass. Installation took one week per side. The types of knots are varied; however, the focus is on western knots. The turquoise blue paint for the backdrop is meant to be reminiscent of Arizona and the West. The dedication for the artwork is set for Friday, May 3, at 10:00 a.m. at the Drinkwater Underpass.

A motion was made by Kathy Duley and seconded by Jeff Miller to approve Drinkwater Underpass Artwork Completion, *Breakaway*, artist Barbara Grygutis. The motion passed unanimously.

4b. Consider Motion to Approve Accession of *Tom's Thumb Rocks*, 2024, 18 x 24" framed acrylic on canvas, artist Gale Goldwoman – Kati Ballares, Director of Public Art

Kati presented *Tom's Thumb Rocks* by Gale Goldwoman from the ColorLove winter exhibition at Civic Center Library Gallery. The artwork is valued at \$2,000 however, Gale agreed to sell it to SPA for \$1,500. The purchase has been reviewed and approved by the Acquisitions Committee and now it being presented to the advisory board.

A motion was made by Jaime Neufer and seconded by Janet Sandino to approve Accession of *Tom's Thumb Rocks*, 2024, 18 x 24" framed acrylic on canvas, artist Gale Goldwoman. The motion passed unanimously.

5. UPDATES

5a. Temporary Art – Tanya Galin, Public Art Manager

- Tanya presented photos of three newly completed temporary art projects. The plinth on Scottsdale Road and Oak Street now features artwork by Nicole Davy titled, *Desert Bloom* that commemorates the influence of being born and raised in the Arizona desert. The plinth on Scottsdale Road and Roosevelt Street now features artwork by Zach Valent titled, *Oh Devil!* is an ode to Arizona's dust devils. The SRP pipe mural on Thomas Road and 82nd Street, called *A Gathering Place* by Shela Yu, celebrates the mutual necessity for water between people, plants, and animals.

- Tanya updated the board that the installation date for *TriHexCirc* by artist Phillip K. Smith has been set for May 30. It is in the final stages of fabrication in Denver.
