- 1. CALL TO ORDER- Meeting was called to order at 12:01 p.m.
- 2. CONSENT AGENDA-

2a. Consider Motion to Approve May 8, 2024, Minutes

Jeff Miller moved, seconded by Russell Grossman, to approve the consent agenda as amended. The motion passed unanimously.

3. "Know Your Public Art" Trivia: Water Mark – Elan Mizrahi, SPA Advisory Board Member

### 4. ACTION ITEMS

**4a.** Consider Motion to Approve Raintree Drive Extension Artwork Completion, Artist Phillip K. Smith III – Tanya Galin, Public Art Manager

Tanya updated the board on the success of the two-week installation of the final artwork for *TRI-HEX-CIRC*, including photos. Extending over 50' vertically to the sky, *TRI-HEX-CIRC* engages directly with the movement of the sun to create an ever-shifting light and shadow icon for North Scottsdale. Twisting from a 4'-0" diameter circle at its base to a hexagon to an 8'-0" sided triangle at the top, the entire sculpture is cut at 30 degrees creating 32 slices, all 12" high. The gap between each slice expands as the artwork lifts upward, allowing the desert air and sky to enter into the artwork while creating a sense of float. Driving around the roundabout, *TRI-HEX-CIRC*'s geometrically precise surface reveals a varying canvas composed entirely of light and shadow, radically changing throughout the day. The artist budget was \$772,608. Plans for a dedication are being determined.

Jaime Neufer made a motion, seconded by Elan Mizrahi to approve Raintree Drive Extension Artwork Completion, Artist Phillip K. Smith III. The motion passed unanimously.

4b. Consider Motion to Approve FY 25-29 Art Plan - Kati Ballares, Director of Public Art

Kati presented an expanded art plan to the board for FY 25-29, including CIP projects, AIPD projects, possible new projects, temporary art projects, FY 24-25 exhibitions, and regular and one-time conservation/restoration projects over the next 10 years. A robust list of completed projects, awards, and accomplishments from FY 23-24 was also included.

Jaime Neufer made a motion, seconded by Russell Grossman, to approve the FY 25-29 Art Plan. The motion passed unanimously.

- Cactus Mirage: Rust was found on the metal structure from a waterslide behind it. Re-installation was a success. Extra acrylic panels were stored for future replacement. The project is complete.

- Water Mark: The walls facing the horses were repainted, and post damage was repaired, completing the project.
